During the month of October 2021, I received information regarding an individual named Misty Gilley selling fentanyl and cocaine out of her place of business and her home. The business is a substance use recovery center named **Simply Recovery** and it is located at 499 N SR 434 Suite # 1073, Altamonte Springs, Seminole County, Florida. Gilley's place of residence [REDACTED] is 812 2nd Street, Altamonte Springs, Seminole County, Florida.

During the month of October 2021, the Seminole County Sheriff's Office, City/County Investigative Bureau (CCIB) conducted a controlled buy (buy/walk) operation utilizing a confidential informant from Gilley's place of business, Simple Recovery located at 499 N SR 434 Suite # 1073, Altamonte Springs, Seminole County, Florida.

The Confidential Informant used phone number [REDACTED] to speak with Gilley to set up the meeting location and the agreed upon drug sale. Gilley met with the Confidential Informant inside her place of business, Simple Recovery located at 499 N SR 434 Suite # 1073, Altamonte Springs, Seminole County, Florida and completed a drug transaction for .2 grams of fentanyl for forty dollars of US currency.

The suspected fentanyl was field tested with a presumptive positive for fentanyl by me.

Additionally, during the month of October 2021, the Seminole County Sheriff's Office, City/County Investigative Bureau (CCIB) conducted a controlled buy (buy/walk) operation utilizing a confidential informant from Gilley's residence, located at 812 2nd Street, Altamonte Springs, Seminole County, Florida.

The Confidential Informant used phone number [REDACTED] to speak with Gilley to set up the meeting location and the agreed upon drug sale. Gilley met with the Confidential Informant at Gilley's residence, located at 812 2nd Street, Altamonte Springs, Seminole County, Florida and completed a drug transaction for .7 grams of fentanyl for one hundred sixty dollars of US currency. The suspected fentanyl was field tested with a presumptive positive for fentanyl by Agent Troy Holland.

Based on the facts of the case presented above that occurred in October, 2021, Gilley violated F.S.S. 893.13.1a1- FENTANYL- SELL SCHEDULE I (TWO COUNTS)

During the month of October while working in an undercover capacity, I made contact with Gilley on two separate occasions to gather information pertaining to the services offered at Simply Recovery. [REDACTED]

On October 25, 2021 Agents with the City/ County Investigative Bureau served a search warrant at Simply Recovery, 499 N SR 434 Suite # 1073, Altamonte Springs, Seminole County, Florida. The warrant was signed on October 22, 2021, by Honorable Judge Woodard. A second search warrant was served at 812 2nd Street, Altamonte Springs, Seminole County, Florida. The warrant was signed on October 25, 2021 by Honorable Judge Krause.

Gilley was present during the search warrant at 499 N SR 434 Suite #1073, Altamonte Springs, Seminole County, Florida. During the search of the treatment facility's medical appointment room, one tan backpack was located hanging behind the second desk near the shelving. [REDACTED] Within the tan backpack, inside a black box was multiple used needles, approximately one gram of suspected fentanyl and one gram of suspected cocaine base. The fentanyl was located within (18) eighteen separate 1x1 baggies and the cocaine base was located inside a contact lenses case. Also inside the contact lenses case were multiple bloody filters. These filters are indicative of intravenous drug use. Also inside the tan backpack were (2) two prescription bottles with the name "Misty Gilley". The suspected fentanyl was field tested with a presumptive positive for fentanyl. The suspected cocaine base was field tested with a presumptive positive for cocaine.

A small garbage can located inside the group therapy room was filled with multiple 1x1 baggies with suspected fentanyl residue. Along with the baggies were multiple bloody tissues, bloody filters, and used needles. It appeared the therapy room was being used for drug use activities.

Located on a gray filing cabinet within the business was a white iPhone XR in a clear plastic case. Agents on scene called Gilley's known telephone number used in previous drug sales, [REDACTED]. The white iPhone XR in the clear plastic case began to ring, indicating the iPhone belonged to Gilley.

During the search at the residence, 812 2nd Street, Altamonte Springs, Seminole County, Florida, (11) eleven 1x1 baggies were located within Gilley's bedroom with suspected fentanyl residue.

The suspected fentanyl was field tested with a presumptive positive for fentanyl.

Based on the facts of the case presented above that occurred on October 25, 2021, Gilley violated F.S.S. 893.13.6a- COCAINE POSSESS, F.S.S.893.13.1a1- OPIUM OR DERIV- POSSESS WTH INTENT TO SELL MFG DELIV SCHEDULE I OR II, F.S.S. 893.147- DRUG EQUIP-POSSESS AND OR USE, and F.S.S. 934.215- PUBLIC ORDER CRIMES USE 2 WAY COMM DEVICE TO FACIL FELONY

After interacting with Gilley on multiple occasions while working in an undercover capacity, it is clear Gilley was running a substance use treatment center, providing addiction therapy services, and medication assisted treatment access. After serving both search warrants, it is also clear Gilley was running a facility targeting a vulnerable population, and preying on those looking for hope while battling a vicious disease.
